Spotlight on United Water Conservation District Well Pump Sequencing



United Water Conservation District (UWCD) manages the water resources of the Santa Clara River, working to protect, conserve and enhance the region's water supply. UWCD enrolled in SoCalREN in 2015 to identify opportunities for improved energy efficiency in their groundwater sourcing and distribution systems.

After completing a series of pump overhaul projects in partnership with SoCaIREN and the WISE ™ program, SoCaIREN's Public Agency Team worked with UWCD's on their control system, adding real-time power and flow monitoring and shifting run hours to their most efficient pumps while still meeting demand and water quality requirements. The project achieved:

- Over \$196,000 in annual energy cost savings
- Over \$70,000 in utility incentives
- · Over 1.8M kWh annual energy savings and 205 kW peak demand savings captured
- Over 2000 metric tons of CO2 avoided (GHG reductions), equivalent to more than 430 cars off the road for one year

These energy savings were nearly three times larger than initially estimated, which, although exciting, created some unique challenges. SCE and the CPUC's Energy Division conducted multiple rounds of project review, and requested an extended measurement and verification (M&V) period after installation to ensure savings projections were accurate even during peak water demand season. Through this process, UWCD learned that big project changes, even when positive, can create challenges when pursuing utility incentives. They also learned that controls projects after a capital improvement project cost. SoCalREN recommends this phased approach for other public agency water suppliers in order to maximize energy cost reduction.
